On June 29, 2024 the Commission will host a Tea with Commissioners event with other Commissioners in our area: Boston Mayor's Advancement, Brookline Women's Commission, Chelsea Women's Commission, Massachusetts State Commission. This event is to create bonds between the different commissions and hear what the major concerns are that commissions see. The event will be held at Junior League, 117

Newbury Street, Boston. The programming will be relatively simple as the point of this event is networking. In our 2025 Annual Report we will provide an update.
