

INTRODUCTION

Bill SD.699 established a permanent Plymouth County Commission on the Status of Women (PCCSW) on January 1, 2018. This Commission, composed of 9 appointed members, is charged with conducting an ongoing study of all matters concerning women in the communities within Plymouth County. The Commission must annually report its findings to the Massachusetts Commission on the Status of Women and recommend solutions to the challenges women and girls are facing in Plymouth County.

The Department of Transitional Assistance (DTA) assists and empowers low-income individuals and families to meet their basic needs, improve their quality of life, and achieve long term economic self-sufficiency. DTA serves one in six residents of the Commonwealth with direct economic assistance (cash benefits) and food assistance (SNAP benefits), as well as workforce training opportunities.

SNAP Food Stamps

SNAP benefits include:

- Monthly funds on an EBT card to buy food
- \$20 a month put back on your EBT card when you use SNAP to buy local produce via the Healthy Incentives Program (HIP)
- SNAP Path to Work free education and training opportunities
- Free nutrition education classes and resources
- Connections to other kinds of help, like utility discounts, free school meals, and discounted admissions to many Commonwealth museums and cultural institutions via EBT Card to Culture

Economic Assistance (TAFDC/EAEDC)

Transitional Aid to Families with Dependent Children (TAFDC) and Emergency Aid to the Elderly, Disabled and Children (EAEDC) are administered through the Department of Transitional Assistance (DTA).

These benefits include:



The Smith Family Housing Resource Center will offer:

- 128 shelter beds for individual adults ages 18+.
- A commercial kitchen providing daily meals.
- Ample space for day services and programming.
- An on-site community health center that will be operated by Brockton Neighborhood Health Center (BNHC).
 - Partial services will be available at the time of opening. (Full services will be provided shortly after the HRC opening.)
- Private meeting spaces for case management and housing navigation.

This new facility reflects their <u>housing resource center model</u>, designed to reduce barriers and improve outcomes by co-locating essential services in one place. Rather than simply offering a bed, they offer a path forward—one that connects individuals with housing, healthcare, and hope.

Father Bill's & MainSpring's mission is to end and prevent homelessness in Southern Massachusetts with programs that provide emergency and permanent housing and help people obtain skills, jobs, housing, and services. They are committed to moving people out of temporary shelters and into a home of their own. They believe in the innovative Housing First approach to ending homelessness.

Project Bread works to break the cycle of hunger by making it easier for everyone in Massachusetts to access and afford food with dignity. Project Bread funds hundreds of food pantries, soup kitchens, and food banks all over Massachusetts. They run the only statewide hunger hotline, the Food Source Hotline (see below), which receives 35,000 calls a year from families in need. Project Bread partners with school districts to offer breakfast programs and summer lunch programs so children can get a nutritious meal even when school is out. On the first Sunday in May each year, they host the Walk for Hunger, the oldest continual pledge walk in the country.

They can give you a copy of your application (along with the date/time you submitted it), and they can give you a checklist of the documentation you will need to submit to DTA.

<u>WIC</u> is a nutrition program that provides healthy foods, nutrition education, breastfeeding support, and referrals to healthcare and other services, free of charge, to Massachusetts families who qualify.

You can participate in WIC if you:

- Live in Massachusetts
- Have a nutritional need (WIC staff can help you determine this)
- Are a child under 5, a new mom, or a pregnant or breastfeeding woman
- Have a family income less than WIC guidelines

You are automatically income eligible for WIC if you currently receive:

- MassHealth/Medicaid insurance plans
- Supplemental Nutrition Assistance Program (SNAP)
- Transitional Aid to Families with Dependent Children (TAFDC) or cash assistance

Separate shelter services are available for individuals and for people with children (including pregnant people). There are also resources for households at risk of foreclosure or eviction, looking for support services, and individuals experiencing domestic violence.

For Families:

Eligibility for Apply for Emergency Assistance (EA) Family Shelter You can apply if:

- You're a resident of Massachusetts
- Your family's gross income* is at or below 115% of the Federal Poverty Guidelines (FPG)
- You're pregnant or have a child under 21

And if the reason you need shelter is one of the following:

- No-fault fire, flood, natural disaster, condemnation, or foreclosure
- Fleeing domestic violence (current or within past 12 months)
- No-fault eviction
- Your children are exposed to a substantial health and safety risk

A family may include parents or guardians, spouses, siblings, stepparents, stepsiblings, or halfsiblings.

The Residential Assistance for Families in Transition (RAFT) program provides short-term emergency funding to help you with eviction, foreclosure, loss of utilities, and other housing emergencies.

RAFT provides up to \$7,000 per 12-month period so your family can stay in your current home or move to a new one. You may use the money for rent, utilities, moving costs, and mortgage payments.

This special exam is important for many reasons: to ensure the health and well-being of the child, to diagnose and treat medical conditions that may be related to the sexual abuse, and to document any possible physical and forensic evidence findings.

For children to be eligible for a Confikids award, they must:

- Be in grades 1-8
- Be a resident of Barnstable, Bristol, Norfolk, or Plymouth counties in Massachusetts
- Meet Confikids financial eligibility requirement by submitting any one of the following letters:
- 1) a letter from your child's school stating that the child receives free lunch based on a financial need. Typically, this letter is called a Direct Certification letter. (Schools are serving free lunch per the state's free lunch policy, but to meet Confikids' financial need requirement, we need to receive the letter from the child's school stating that the child receives free lunch based on a financial need, NOT a letter referencing the free lunch program offered by the State Massachusetts.)

OR

2) a copy of a current MA Supplemental Nutrition Assistance Program (SNAP) letter

OR

3) a current MA Transitional Aid to Families with Dependent Children (TAFDC) letter.


